## PEKELILING AM BIL. 1/2011

### KAEDAH-KAEDAH (PINDAAN) ARKITEK 2011

Pekeliling Am ini dikeluarkan untuk memaklumkan semua ahli berdaftar bahawa Kaedah-Kaedah (Pindaan) Arkitek 2011 telah diwartakan dan mula berkuatkuasa pada 1 Jun 2011.


Pindaan utama meliputi perkara berikut :-

1. Kaedah 22 - “(3) Tiap-tiap Pereka Bentuk Dalam yang berhasrat untuk membaharui pendaftarannya di bawah subsekyen 27C(4) Akta hendaklah memohon kepada Lembaga secara bertulis pada atau sebelum 31 Januari bagi tahun berikutan tahun pendaftarannya habis tempoh, dan permohonan itu hendaklah disertakan dengan fi pembaharuan sebagaimana yang ditetapkan dalam Bahagian Dua Jadual Pertama.”
2. Kaedah 24 - “(1B) Mana-mana Pereka Bentuk Dalam yang namanya telah dikeluarkan daripada Daftar menurut perenggan 27H(b) Akta kerana kegagalan memperbaharui pendaftaran hendaklah dalam masa lima tahun dari pembatalan itu, apabila memberitahu Pendaftar akan hasratnya untuk dimasukkan semula menurut subseksyen 27I(2) Akta, secara bertulis menyatakan butir-butir penggajian atau pekerjaannya pada tarikh pemberitahuannya kepada Pendaftar.”
3. Kaedah 28 - “(4) Seseorang Pereka Bentuk Dalam hendaklah dalam menjalankan profesionnya, mematuhi dan berpandukan peruntukan Kod Tatakelakuan untuk Pereka Bentuk Dalam dalam Bahagian Tiga Jadual Kedua.”
4. Kaedah 29 - “(3) Kecuali dengan kelulusan Lembaga yang diberi terlebih dahulu atas sebab khas, seseorang Pereka Bentuk Dalam hanya boleh membuat suatu perjanjian yang melibatkan perkhidmatannya mengikut Syarat-Syarat Guna Khidmat dalam Bahagian Tiga Jadual Ketiga dan Memorandum Perjanjian dalam Bahagian Dua Jadual Keempat.”

5. Bahagian VA yang baru - Bahagian VA mengenai "Pendaftaran Pengamal Perundingan Reka Bentuk Dalaman" dimasukkan.
6. Pindaan Am - perkataan "Pelukis Pelan Bangunan Berdaftar" and "Arkitek Berdaftar" di mana terdapat digantikan dengan "Pelukis Pelan Bangunan" dan "Arkitek Graduan".

Semua Arkitek Profesional, Arkitek Graduan, Pereka Bentuk Dalaman dan Pelukis Pelan Bangunan dinasihatkan supaya memperolehi salinan Kaedah-Kaedah Arkitek 1996 (meliputi pindaan sehingga Jun 2011) yang boleh dimuat turun dari laman web LAM. Dokumen tersebut boleh juga dibeli daripada pejabat LAM.

## GENERAL CIRCULAR NO. 1/2011

### ARCHITECTS (AMENDMENT) RULES 2011

This General Circular is issued to inform all registered members that the Architects (Amendment) Rules 2011 had been gazetted to come into force on 1 June 2011.

The main amendments include the following :-

1. Rule 22
  - “(3) Every Interior Designer desirous of renewing his registration under subsection 27C(4) of the Act shall apply to the Board in writing on or before 31 January of the year following the year of expiration of his registration, and such application shall be accompanied with the renewal fee as prescribed in Part Two of the First Schedule.”
2. Rule 24
  - “(1B) Any Interior Designer whose name has been removed from the Register pursuant to paragraph 27H(b) of the Act for failure to renew his registration shall within five years of such removal, when notifying the Registrar of his desire to be reinstated pursuant to subsection 27I(2) of the Act, in writing state the particulars of his employment or occupation as on the date of his notification to the Registrar.”
3. Rule 28
  - “(4) An Interior Designer shall in the exercise of his profession, observe and be guided by the provisions of the Code of Conduct for Interior Designer, in Part Three of the Second Schedule.”
4. Rule 29
  - “(3) Except with the prior approval of the Board given for special reasons, an Interior Designer shall only enter into an agreement for his services according to the Conditions of Engagement in Part Three of the Third Schedule and the Memorandum of Agreement on Part Two of the Fourth Schedule.”

5. New Part VA - Insertion of Part VA on the “Registration of Interior Designer Consultancy Practice”.
6. General Amendments - the word “Registered Building Draughtsman” and “Registered Architect” wherever appearing be replaced with “Building Draughtsman” and “Graduate Architect” respectively.

All Professional Architects, Graduate Architects, Interior Designers and Building Draughtsmen are advised to obtain a copy of the Architects Rules 1996 (incorporating amendments up to June 2011) which may be downloaded from LAM’s website. The document may also be purchased from LAM’s office.
