GENERAL CIRCULAR NO. 1/2017

ARCHITECTS RULES 1996 (Amendment 2015) and ARCHITECTS (SCALE OF MINIMUM FEE) RULES 2010

This General Circular is issued to remind all Architects:

On the compliance to Architects Rules 1996, Third Schedule [Rule 29] – Conditions of Engagement of an Architect [Sub-rule 29(1)], which requires the Architect providing Architectural consultancy services to be in accordance with the Memorandum of Agreement between the Architect and the client; and

On the compliance to the Architects (Scale of Minimum Fees) Rules 2010, which requires the architectural consultancy services provided by the Architect to be in accordance with the Rules.

It is **MANDATORY** for architectural consultancy practice to charge their professional fees according to the Architects (Scale of Minimum Fees) Rules 2010 which has come into force from 1st March 2010.

The Board may from time to time request for proof of compliance.

Berkenaan pematuhan kepada Kaedah-Kaedah Arkitek 1996, Jadual Ketiga [Kaedah 29] – Syarat Penglibatan Arkitek [Sub kaedah 29(1)], yang mengkehendaki Arkitek yang menawarkan perkhidmatan Perundingan Arkitek agar selaras dengan Memorandum Perjanjian di antara Arkitek dan Klien; and

Berkenaan pematuhan kepada Skala Fi Minimum Arkitek, Kaedah 2010, yang mengkehendaki Arkitek yang menawarkan perkhidmatan Perundingan Arkitek agar selaras dengan Kaedah tersebut.

Hal ini adalah **WAJIB** dipatuhi oleh firma perunding Arkitek bagi mengenakan caj bayaran selaras dengan Kaedah-kaedah (Skala Fi Minimum) Arkitek 2010 yang mana telah berkuat kuasa mulai 1 Mac 2010.
